

EFO introduced the NEQLP in 2011 to assist individuals coming into the Ontario egg industry. At that time, EFO noted that the NEQLP would be reviewed/evaluated after five years.

Subsequently, the NEQLP program will be placed on hold during the review process.

As part of EFO's [2016] review process, a survey was forwarded to the other provincial egg organizations requesting information about their current or proposed New Entrant program.

But the new entrant quota and any subsequent quota increases distributed pro-rata to all existing producers (again at \$25/bird) remain the right of the producer to produce. Quota remains in their control as long as they meet all the licensing requirements as set out in our Licensing Board Order or until such time as they transfer/sell.
