

Egg Farmers of Ontario (EFO) hosted the MPP Omelette Breakfast at Queen's Park on November 1. The annual breakfast was open to all Members of Provincial Parliament (MPPs) and their staff as a thank you for their all-party support of agriculture in Ontario.

With several omelette stations organized, EFO's Board of Directors were kept busy making custom omelettes for the 51 MPPs that attended, which included 12 Ministers. They were joined by more than 140 legislative staff.

The Honourable Lisa Thompson, Minister of Agriculture, Food and Rural Affairs attended the breakfast, where she also brought greetings to guests. Comments were also provided from John Vanthof, MPP (Temiskaming-Cochrane); Stephanie Bowman, MPP (Don Valley West); and

INDUSTRY updates

Agricultural Adaptation Council (AAC)

In their October update, AAC shared an announcement regarding a program launched by the Ontario government called the *Veterinary Incentive Program*. This is to encourage new veterinarians to practice in northern and underserved Ontario communities. The funding will provide grants of up to \$50,000 over a five-year period to vets that provide care to livestock and poultry in these communities.

This program is being delivered by the AAC – to learn more, visit adaptcouncil.org/program/vip.

AAC is still accepting applications for the *Increasing Deadstock Capacity Initiative* until February 1, 2025. Eligible organizations can apply for cost shared funding to a maximum of \$100,000 per project. For more information, click [here](#).


HISTORIC SIGNING HELD AT QUEEN'S PARK

Price Change Effective November 5 - REVOKED

Price Determination Order 03-2023, effective November 5, 2023, has been revoked, and Price Determination Order 02-2023 (originally effective Sunday, July 16, 2023) remains in effect. The decision to delay the implementation of the price increase, originally planned for November 5, was made to help stabilize the supply chain for industry stakeholders and consumers, and was based on the most recent cost of production information and current market conditions.

Pricing will be re-evaluated during the first pricing period in 2024, based on the most recent information available and adjusted accordingly.

Notice: Levy & Licence Fee Change - INCREASE

Egg Farmers of Canada (EFC) has implemented a 12-cent levy increase effective November 5, 2023. In order to help minimize impacts, effective November 12, 2023, Egg Farmers of Ontario (EFO) is cost-sharing this levy increase with Ontario egg farmers. This means that 4 cents will be paid by an Ontario egg farmer and 8 cents will be paid by EFO from their internal reserves. EFO's Board will re-evaluate this cost-sharing arrangement each time a Cost of Production (COP) report is released.

Therefore, effective November 12, 2023, the levy for Ontario egg farmers will be as follows:

Previous Producer Levy: 39.95 cents
 New Producer Levy: 43.95 cents
 New Producer Levy for Zone 9N: 42.95 cents

Grading station voluntary research fee .02 cents (not to be deducted from the producer).

CHORIZO SHAKSHUKA



Servings: 4
Prep Time: 20 minutes
Cook Time: 20 minutes

INGREDIENTS

1 ½ cups (375 ml) chopped semi-dry cured chorizo sausage
1 small red pepper, diced
½ onion, diced
1 clove garlic, minced
½ tsp (2 ml) caraway seeds
¼ tsp (1 ml) each smoked paprika, cayenne pepper and cumin
¼ tsp (1 ml) each salt and pepper
1 (796 mL) canned diced tomatoes
4 eggs
½ avocado, diced
¼ cup (60 ml) each cilantro and parsley leaves
Crusty toasted bread to serve

DIRECTIONS

Preheat oven to 400°F (200°C).

Heat a large, oven-proof skillet over high heat. Sauté chorizo, red pepper, onion, garlic, caraway, paprika, cayenne, cumin, salt and pepper for 2 to 3 minutes, until onions are translucent and spices are fragrant.

Stir in tomatoes and bring to a simmer; let cook uncovered for 5 minutes to reduce some of the liquid. Remove from heat.

Make 4 shallow wells in sauce and add an egg to each well. Bake in oven for 8-10 minutes or until whites are just set and yolks are runny.

Garnish with avocado, cilantro and parsley. Serve with toasted bread.

Nutrients per serving (¼ recipe eggs in sauce only): 270 calories, 13 g total fat, 970 mg sodium, 19 g carbohydrates, 6 g fibre, 10 g sugars, 20 g protein.

“eggs-pert” advice

TIP: Make sure whatever you're filling your omelette with is already cooked. Use ingredients that are not going to produce a lot of water when warmed.



Education Pilot Underway

The *Farm to Table Student Eggs-perience* program pilot officially got underway on October 1st.

The in-class portion of the three-part program, has been presented by farmer educators across Ontario, with 17 presentations in Zones 1, 3, 4, 5, 6, 7, 8 and 10 to date.

Parts two and three of the pilot are teacher-led, and they focus on the grading station and the grocery store.

The pilot phase of the program will continue into the spring of 2024, after which final feedback from both farmers and teachers will be reviewed with an eye to highlighting the strengths of the program and implementing necessary improvements.

Teacher feedback to date has shown great enthusiasm for the pilot.

The third and final *Breakfast on the Farm* event was held on October 21st at Laprise Farms in Pain Court, Ontario. As a guardian sponsor, EFO had a display at the breakfast, where farmers were available to answer consumer questions.
